
Meeting summary of the seventh annual

Shuswap Trails Roundtable

December 2nd 2020 Held virtually via Zoom

Introduction

Approximately 70 leaders and representatives from various orders of government including Secwepemc, local, regional, and provincial, as well as from trail user groups, stewardship groups, health organizations, tourism, and the forest industry met virtually via Zoom from various locations around the Shuswap for the seventh annual Shuswap Trails Roundtable. The objectives for the Roundtable meeting were as follows:

- Learn about the BC Trails Strategy
- Here an update on the progress of the Shuswap Regional Trails Strategy this year
- Seek feedback on priorities for the Shuswap Regional Trails Strategy, and endorse the annual work plan
- Convene all trail user groups, build relationships, and share information.

Welcoming comments

Mike Simpson opened the Roundtable meeting at 9:30 am. He welcomed everyone, and introduced Louis Thomas from Neskonlith Indian Band, Secwepemc Nation. Louis provided a traditional welcome.

Mike then introduced himself as the facilitator for the day. He acknowledged Secwepemc Territory. Next, Phil McIntyre-Paul introduced himself on behalf of the Shuswap Trail Alliance, and expressed his thanks for the incredible contribution of all the Roundtable members.

Mike explained that a full round of introductions wouldn't be possible due to the large number of participants in the Zoom meeting. He then reviewed some Zoom etiquette protocol.

Next, Mike briefly reviewed the role and membership of the Roundtable. He also acknowledged the Working Group, which is a sub-set of the Roundtable that meets quarterly.

<u>BC Trails Strategy Update - presented by Tennessee Trent, BC Ministry of Forests,</u> <u>Lands, Natural Resource Operations</u>

Tennessee introduced himself and acknowledged Ktunaxa and Syilx Territory, from where he joined the Roundtable meeting from his home in Nelson.

He introduced the BC Trails Strategy as being developed in 2010 and adopted by the provincial government in 2012. The Strategy has a Vision for a world-renowned sustainable network of trails, with opportunities for all, which provide benefits for trail users, communities and the province. There are several guiding principles, and six key

components. Tennessee mentioned that the Shuswap Regional Trails Strategy aligns with the provincial Strategy.

Tennessee highlighted Action #21 within the Strategy, which states the Province should establish a provincial trails advisory body ("PTAB") to provide direction and advise government on implementation of the Strategy. He explained that the PTAB is a partnership of several organizations including BC Ministry of Forests, Lands, Natural Resource Operations and Rural Development, BC Ministry of Environment and Climate Change Strategy, BC Ministry of Tourism, Arts, and Culture, BC Ministry of Transportation and Infrastructure, Outdoor Recreation Council, BC Wildlife Federation, Wilderness Tourism Association, and BC Recreation and Parks Association.

The Strategy underwent a comprehensive review recently, including literature review, First Nations engagement, and stakeholder engagement. Tennessee explained that engagement done to-date has had very good response from various parties, including the general public, First Nations governments, and local governments.

'Snapshot' Project Updates - part 1

Linda Buchanan, (Backcountry Horsemen, Shuswap chapter) reported that their group has had a great year with regard to trail work at Skimikin. The BCH, as well as Back Country Shuswap Riders, received grant funding that went toward posts and signage; posts have been installed and signage will be put up this winter. Two large kiosks have also been installed: one at the ATV campsite and the other at the main parking area. Trail clearing and maintenance was also done this year. She also reported that the Landmarks Project is making progress, including trail signage and organizing an elders' site visit (the latter was challenged by Covid restrictions). Additionally, Chris Lynd reported that some significant clean-up efforts have been done in the Skimikin back-country with the help of BC Conservation Officer Service and Rec Sites & Trails staff.

Chris Lynd also reported that some of the Offroad Vehicle Fund is going toward the development of trail kiosks. He acknowledged the importance of kiosks in informing, educating, and guiding trail users.

Louis Thomas reported that the Secwepemc Traditional Plants project is underway and has secured funding from Agriculture and Agri-Foods Canada. The purpose of the project is to re-establish harvest areas for traditional plants. Parks Canada has provided a harvest area in the Revelstoke area.

Louis Thomas also reported on the West Bay Connector project. A Memorandum of Understanding was signed by Neskonlith Indian Band, Adams Lake Indian Band, and City of Salmon Arm early in 2020. The Working Group as able to participate in the signing ceremony. Phil McIntyre-Paul reported that some Covid relief funding has been released by the Province, and these funds will support hiring a contractor to keep this project moving.

Shuswap Trails Roundtable Business

Mike briefly touched on the Roundtable meeting summary from November 2019, and asked for comments.

Phil presented the Roundtable Annual Summary Report for 2020, highlighting the Working Group quarterly meetings, as well as work done on advocacy, tourism promotion, mapping and GIS, Secwepemc learning, recreational access management planning, and regional partner-led legacy initiatives.

Jen Bellhouse presented a financial summary for 2020. She noted that the revenue was down this year, but some savings were accrued due to not holding meetings in person. She explained that there is a conservative budget developed for 2021.

Sub-regional Discussions

Participants broke into one of seven small groups to discuss work underway and priorities in the sub-regions. Mike suggested that the groups focus their conversation on identifying the top three priorities for the sub-regions in 2021.

<u>Inner Shuswap</u> - Carmen Massey reported the top priorities:

1. Encourage development of a new group to represent the needs of motorized trail users in the Inner Shuswap

2. Complete the South Shuswap Destination Trail Master Plan, particularly the

Cinnemousun trail plan, to clarify best uses and access management

3. Move forward with all-access trail development in BC Parks Cedar Creek near White Lake. BC Parks is working with People In Motion. Additionally, re-locate the forestry road out of the riparian area near White Lake.

East Shuswap - Adrian Bostock reported the top priorities:

- 1. Education and engagement with users regarding backcountry use etiquette
- 2. Eagle Pass Lookout management plan
- 3. Gorge FSR joint agreement with all users and groups, and third party moderator if needed
- 4. Joss Mountain is awaiting a report from a biologist, and completing a management plan.

Ryan Nitchie further added that the CSRD was gifted a large piece of parkland property by the Ritchie family in the Malakwa area along the Eagle River; CSRD is budgeting funding for the development of a blue-way trail to access the park via Eagle River.

Jim Cooperman also commented that the English Creek bouldering area near Revelstoke is growing in popularity and is in need of an outhouse.

<u>Shuswap River</u> - Phil McIntyre-Paul reported the top priorities:

1. Developing regional trail connections between various communities and locations including Sicamous - Armstrong - Vernon - Osoyoos rail trail; Armstrong - Deep Creek - O'Keefe Ranch; Vernon - Silver Star - Trinity-Ricardo - RDNO Area F - Lumby -

Spallumcheen. The current planning processes for these initiatives need to be linked to realize these opportunities.

2. Working with partners such as Splatsin, Okanagan Indian Band, BC Parks, BC Rec Sites and Trails to maintain values along the rail trail

3. Bring the sub-group back together to continue the conversation.

Falkland - no sub-group

<u>Salmon Arm Bay</u> - Janet Aitken reported the top priorities:

1. Collaborative work by the City of Salmon Arm, SABNES, and Shuswap Trail Alliance to build, upgrade, and maintain trail along the bay; also upgrading bird viewing platform 2. West Bay Connector, safety for pedestrians is a big concern. A grant application is in the works to support planning for this connector trail. There is a long-term goal of a trail from Canoe to Sunnybrae.

3. Invasive species prevention and management. There is still no evidence of bullfrogs, zebra or quagga mussels in the Shuswap. Invasive Asian clams were discovered earlier this year.

North Shuswap - Debbie Seymour reported the top priorities:

1. A North Shuswap community group is working on developing a parallel pathway from RaceTrac Gas near Little River Bridge to St. Ives; community surveys have identified three segments along this route for priority development (Ross Creek - Bristow Road Park; Ross Creek - Lakeview Park; connecting existing pathways within Scotch Creek)

2. More development and maintenance for ATV and snowmobile trails, including signage and mapping

3. Developing the Lee Creek Bluffs trail; next steps include community engagement.

Ryan Nitchie further added that CSRD has budgeted \$75,000 for preliminary survey and planning in 2021 for the parallel trail listed in #1, above.

<u>West Shuswap</u> - Brock Endean reported the top priorities: 1. Continue work on the South Shuswap Destination Trail, partly in recognition as a significant economic initiative; 2. Complete a Section 57 for Skimikin; 3. Re-locate the forestry road at White Lake and construct new trail at Cedar Creek (White Lake Provincial Park). Overall, forging and sustaining partnerships are a high priority.

Shuswap Trails Roundtable Business - part 2

Phil reviewed continuing and emerging priorities for the Roundtable in 2021, highlighting securing Roundtable funding to keep proceeding, maintaining information-sharing through

the Working Group, continuing to advocate for collaborate land management with the Province; continuing to use the Secwepemc referral process, continuing the Secwepemc Landmarks project, expanding use of the Shuswap Trail Strategy's structured adaptive management planning, securing funding for adaptive planning including for cumulative effects assessment, continuing to coordinate master trail mapping, and continuing to coordinate trail-based tourism promotion.

Snapshot Project Updates - part 2

Phil reported that the Sicamous-to-Armstrong Rail Trail is proceeding. The governance committee has been meeting every two months, the technical committee has been meeting even more frequently. There is a development plan ready, and is posted online at https://shuswapnorthokanaganrailtrail.ca. It is now in the implementation stage, with the current challenge being how to best leverage funding. Alex de Chantal has been hired to coordinate fundraising and financial management for the project.

Libby Chisholm reported that the Secwepemc Landmarks project is proceeding. An elders' workshop was held earlier in the year, and surveys are currently underway to collect further direction from the elders. A grant application for phase 2 has been submitted. Artists are working on sculptures.

Phil reported that the South Shuswap Destination Master Trails Plan has been on pause due to Covid. The next step was supposed to be community engagement, which has not been possible due to the pandemic.

Phil reported that some major recreational initiatives are underway in the East Shuswap, including Joss Mountain and Eagle Pass Look-out. BC Rec Sites and Trails is facilitating the progress on these projects with the involvement and support of many partners.

Upcoming Events in 2021

Garfield Chursky announced that Shuswap Dirt Riders will be doing spring cleanup, everyone is welcome to join.

Brad Vickerson announced that several riding groups across the region have been working with Search and Rescue volunteers to make search and rescue efforts go more smoothly.

Phil announced that the annual volunteer trail stewards meeting is tomorrow evening (December 3rd).

Phil further announced that the annual Shuswap Trails Alliance fundraiser will still happen, online, with an auction, in February.

Louis Thomas announced that Coyote will be delivering toys this holiday season

Next steps and closing comments

Mike announced that there will be a Roundtable meeting summary out by mid-December.

The Working Group meeting dates are set for: January 15th, April 16th, June 18th, and October 15th, which follows the third-Friday-of-the-month pattern the Working Group has been using for their quarterly meetings.

Mike also announced that the 2021 Roundtable Workplan will be updated with input heard today, and shared broadly.

Phil McIntyre-Paul re-iterated his appreciation to all Roundtable members, especially for participating virtually, and lamented over not being able to meet in person. He thanked Secwepemc and provincial government leadership for their patience and generosity.

2020 Progress Summary:

Quarterly Working Group – met in person in January and continued to meet via Zoom in April, June, and October

Maintained regional project and information sharing/consultation at working group meetings

Advocated for four year Roundtable funding strategy (see below) – framework to include shared financial support from all orders of government, in-kind support from stewardship and sector organizations, administration support from the Shuswap Trail Alliance, and contracted facilitation support from the Fraser Basin Council. Renewal of commitments needed in 2020 going into 2021.

Maintained Trail-Based Tourism Promotion through Shuswap Tourism and partners, and looking to Secwepemc Lakes Tourism Initiative. NOTE: limited by COVID-19 restrictions and budget cuts in 2020.

Continued to grow central map database of regional trails through CSRD GIS department.

Advocated for Recreational Access Management Plans integrated into broader comprehensive land management plans, including priority pilots: Joss-Tsuius-Mabel Alpine, Owlhead/Blue Lake/Hunters Range, Eagle Pass Mountain, Gorge Winter Backcountry Area, Larch Hills Non-Winter, Kela7scen (Mt Ida), Glenemma, and South Shuswap.

Met with MFLNRORD staff re support for Management Planning and Cumulative Effects Assessment, and followed up with Secwepemc leadership regarding Government to Government land management, including the Pespesllkwe te Secwépemc.

Continued growing Secwepemc learning, awareness building, and collaboration each meeting.

- Secure funding to develop structured adaptive planning model that includes capacity for cumulative effects assessment modelling, and support recreational access management planning pilots
- Continue to coordinate master trail mapping files through CSRD GIS department, and follow-up on data sharing agreements with Secwepemc and municipal/regional partner governments
- Continue coordinating trail-based promotion through Shuswap Tourism, and expand promotion to include both motorized and non-motorized recreation, and be guided by/integrated into the emerging Secwepemc Lakes Tourism strategy
