



2018 AGM Report: Executive Director

2017 was a banner year for Shuswap trails despite the chaotic season of floods, wind, and fire, with outcomes in all 5 core pillars of our strategic planning framework.

- ✓ Regional Collaboration (e.g. Trail Strategy, Secwepemc Tourism, Rail Trail, Health, SOLF)
- ✓ Trail Stewardship (e.g. volunteer events, trail report hotline, stewardship training)
- ✓ Environmental Adaptive Planning (e.g. CSISS Play-Clean-Go, foreshore monitoring, TEST)
- ✓ Experience Development (e.g. Shuswap Trail Guide/Website, TrailRider, Tourism Marketing)
- ✓ Capital projects/technical trail services (e.g. 10 new trails. . .see below)

Trail stewards, volunteers, Secwepemc/municipal/regional/and provincial community partners, funding supporters, clubs, school groups, business teams, Rapattack, the STA trail team, and so many others worked very, very hard successfully adding an incredible 10 new trails in 2017 totaling over 12,000 metres, and installing over 300 new signs – not to mention maintaining 260,000 metres of existing trail.

Regional Collaboration – Huge thanks go out to all the leaders throughout the region who work together to make the Shuswap a healthier place to live, work, and play. It truly is and continues to be a team effort. This includes the hard working Secwepemc, Provincial, regional/municipal, tourism & economic development, trail stewardship clubs & societies, health, education, environmental, and industry leaders who are meeting through the Shuswap Regional Trails Roundtable and the quarterly Working Group. Thank you to all the dedicated Secwepemc, Provincial, Regional, and Municipal staff we have the great privilege of working with every day; the sector agencies who have jumped in deep; the diverse, wise, and talented Shuswap Trail Alliance board and sub-committee members; the Shuswap Trail Alliance management team and trail crew; and the many trail stewardship organizations and volunteers who have dedicated so much of their time. Remarkable! **Kukstemc** (Thank you).

The Shuswap Regional Trails Strategy and Roundtable – The Roundtable continues to grow and evolve as the formal meeting point for all invested in Shuswap trails and their care to work together in a spirit of respect, cooperation, and stewardship to *take care of the land*. . .Y'icwetsutce.

Seventy people from Secwépeḿc, local and provincial governments, along with trail user groups, environmental stewardship, industry, business, economic development, tourism, invasive species and health organizations gathered for the third annual Shuswap Trails Roundtable meeting at the Chase Community Hall in November 2017.

The objectives for the meeting were to provide update on progress of the Shuswap Regional Trails Strategy this year, to seek feedback on priorities for the Shuswap Regional Trails Strategy for next year, and endorse the annual work plan, and convene all trail user groups, build relationships, and share information.

An updated work plan and funding strategy were developed inviting a four-year commitment of support from each of the partners. Commitments have been confirmed by the Provincial Recreation Sites and Trails BC office and the Sexqéltkemoc Secwepemc Lakes Division Chiefs and Councils. Further commitments are pending. The Fraser Basin Council have been contracted to resume facilitation of the Roundtable in 2018 on behalf of the Shuswap Trail Alliance, who are tasked with administering the Strategy and Roundtable on the partners behalf.

10 New Trails in 2017 – despite the crazy wind-flood-wind-fire-wind-snow season we had, trail stewards, volunteers, municipal/regional/and provincial community partners, funding supporters, clubs, school groups, business teams, Rapattack, the STA trail team, and so many others worked very, very hard in 2017. The result is an incredible 10 new trails added (yes 10!), totaling over 12,000 metres. A special word of acknowledgement to the Provincial BC Rural Dividend Program that provided a substantial grant leveraged against our 2017 fundraising to support the 2017 trail building season.

Trail Signage – 385 new greenway trail signs went up in 2017, including signage on the new trails, repairs and updates to the entire Rubberhead Trail System, and the extraordinary push by the District of Sicamous to install over 100 new trail signs throughout the community. Watch for more in 2018.

New Trail Planning – 21 new trail planning projects were initiated in 2017 with the support of regional partners including the CSRD, the City of Salmon Arm, the new Salmon Arm MRDT (Hotel Tax) Fund, the

North Shuswap Lion's Club, and the Provincial Ministry of Forests, Lands, and Natural Resource Operation and Rural Development's BC Rural Dividend Program grant.

Final reviews are underway for new trail work in 2018 to include Balmoral, Gayle Creek, North Fork Wild, Rubberhead, Chase, and South Canoe. Plus there's wider Shuswap Trails round-table planning underway in areas like the Owlhead, Joss Mountain, and Eagle Pass alpine, Larch Hills Traverse, Rubberhead, the Kela7scen (Mt Ida) management discussions, Haines Creek, Glenemma, Scatchard, and Lee Creek, Onyx and Hunakwa in the North Shuswap.

Planning priorities targeted for 2018 also include exploration of potential new Evelyn Falls Trail Extensions (North Shuswap), Scotch Creek/Hlina Trail Extensions (North Shuswap), Mt Ida North Slopes Trail Plan (Salmon Arm), Rubberhead Mountain Bike Trail (Larch Hills/Salmon Arm), Larch Hills Traverse 109 FSR Section (Larch Hills/CSRD Area E), East Shuswap Alpine (Sicamous/CSRD Area E) – including Queest, Anstey, Owlhead, Eagle Pass, Joss, and McPherson/English, and Enderby-to-Mabel Lake Road Corridor along Shuswap River and surrounding area.

2018 will also see blueways being explored for paddle access, invasive species tackled at trailheads, a complete trail guide redo with Shuswap Tourism, more trail signs, even more geo-referenced maps developed in partnership with the CSRD GIS staff, launch of the South Shuswap Destination Trail planning process with CSRD Area C, new developments in the Adams River Pictograph Protection program with BC Parks, Little Shuswap, Adams Lake, and Neskonlith Bands ready for the peak salmon run, further planning to explore the West Bay connectors with the Switzmalph Cultural Society, Neskonlith, Adams Lake, Little Shuswap Bands, and the City of Salmon Arm, and support for the Kela7scen (Mt. Ida) management plan process with Secwepemc leadership. Plus can you say rail-trails?

It will be another pivotal year for Shuswap Trails ahead, particularly in using the trails as a tool for ongoing reconciliation, relationship building between Secwepemc First Nations and the wider communities, and telling the true story of this place that is our home. As expressed at the Joss-Tsuius-Mabel alpine recreational access planning discussion recently hosted by Splatsin and facilitated by the STA - there is a new awakening in the land and an opportunity to work together to manage ourselves differently and well.

Sicamous-to-Armstrong Rail-Trail – The Sicamous-to-Armstrong Rail-Trail took a giant step forward in 2017! The Regional District of North Okanagan and the Columbia Shuswap Regional District successfully concluded the purchase of the CP Rail Corridor between Sicamous and Armstrong. Working in partnership with Splatsin and the regional municipal governments - along with 1/3rd Provincial funding support by MLA Greg Kylo and former Minister of Transport, Todd Stone - the corridor will be "used for recreational opportunities, including walking and cycling, while retaining it for future transportation and economic development needs. There is also long-term potential to connect this corridor to the Okanagan Rail Trail, which is currently under development, connecting the City of Kelowna to the District of Coldstream." The Shuswap Trail Alliance is pleased to continue to support the efforts of the Splatsin and local RDNO/CSRD regional and municipal governments in the next phases of planning and development. It is an unprecedented opportunity to realize what Splatsin Kupki7 (Chief) Wayne Christian and Council have described as telling the true story of this place.

Trail Maintenance – Over 267,000 meters of trail were maintained throughout 2017 (and that’s not including the trails managed by the Larch Hills Nordic Society, the Skmana Ski Club, or the EQ Trail Association at Skimikin!) It was a particularly challenging year with the extreme variables of weather, water, and fire. But trail stewards, regional and provincial land managers, trail clubs, the Shuswap Trail Crew, and volunteers throughout the region came together. We thank the ongoing commitments to support trail maintenance by the CSRD Parks department, City of Salmon Arm, BC Parks, and Recreation Sites and Trails BC, and the particularly significant contribution of the Rapattack crew.

We acknowledge the extraordinary work of the region’s well-established Trail Organizations including the Larch Hills Nordic Society, Shuswap Outdoors, the Skamana Ski Club, SABNES, and the EQ Trail Association. And also the growing new trail advisories and stewardship groups like the South Canoe Trails Advisory, the White Lake Trail Stewards, the Pileateers, Park Hill, and the Shuswap Bike Club.

A new initiative to grow new trail stewardship advisories is underway this year championed by the Shuswap Trail Alliance’s Adrian Bostock and Lori Schneider Wood. Interested in joining one of the new advisories? Email Lori at admin@shuswaptrails.com.

And finally – a great big word of thanks to Glen Pilling who manages the Trail Report hotline. Glen is the uber volunteer who reads all those trees down and flooding issues you send into trailreport@shuswaptrails.com, notes them down on the record table, and then forwards them on to the relevant land managers and trail stewards. Keep those notes coming.

Trail Promotion – work with Shuswap Tourism and regional partners in 2017 included a full update of the Shuswap Trail guide to come out in June this year, which has also allowed us to work through all the online information and look to a full update this season. As well, the CSRD GIS staff have now taken on acting as the central hub for housing all master trail files throughout the Shuswap. They helped us clean up all the existing map files and produced 66 brand new geo-reference pdf maps that can be downloaded from the Shuswap Trails website for printing or use on mobile devices. This year, the GIS team is working with us to upgrade the online Google Earth trail maps which will soon be linked directly to the master files at the CSRD. Yay!

Watch for work on a new mountain bike trail map supplement to compliment the updated Trail Guide in 2018. Local mountain bike leadership are working on assembling focused information along with the new maps, plus continue to update the TrailForks app, thanks to funding through Salmon Arm MRDT.

And a massive thank you to D’Arcy MacLeod who has been doing a spectacular job managing the Shuswap Trails Facebook site. He’s keeping us excited and informed on all things trail-related throughout the Shuswap – and when the news is a little lean, he posts tantalizing photos from his own trail explorations. Thanks to D’Arcy for keeping us so well connected.

Leveraging Partnerships – All Shuswap Trail projects supported through the Shuswap Trail Alliance are based on working partnerships. In 2017 over 50 partners worked together on over 65 projects throughout the Shuswap representing Secwepemc, Provincial, Regional/Municipal orders of government, industry, business, environment, economic development, tourism, health, education, recreational trail user groups, and community residents. Plus over 5400 volunteer hours were logged.

Shuswap trail leadership are giving an especially big shout out of thanks this year to the Provincial Ministry of Forest Range and Natural Resource Operations and Rural Development who awarded a BC

Rural Development Program Grant to assist with trail work in 2017. That was matched with funding from the annual February fundraiser event along with project funding through the CSRD Parks Areas C, D, E, F, the City of Salmon Arm, District of Sicamous, City of Enderby, RDNO Area F, BC Parks, Shuswap Tourism, the Salmon Arm MRDT Hotel Tax Funds, Shuswap Community Foundation, North Shuswap Lions Club, Bike-for-Your-Life, and the Columbia Shuswap Invasive Species Society.

We were successful securing another BC Rural Dividend Grant in 2018 to support further planning throughout the region. Unfortunately, we were not successful in securing a BC Rural Development Program grant for trail building in 2018, but have been asked to reapply for future funding, which we will do. The Salmon Arm MRDT Hotel Tax funding strategy continues to include support for trail planning, signage, and marketing in 2018. Our regional operational grants continue with CSRD Areas C, D, E, F, City of Salmon Arm, District of Sicamous, City of Enderby, and RDNO Area F.

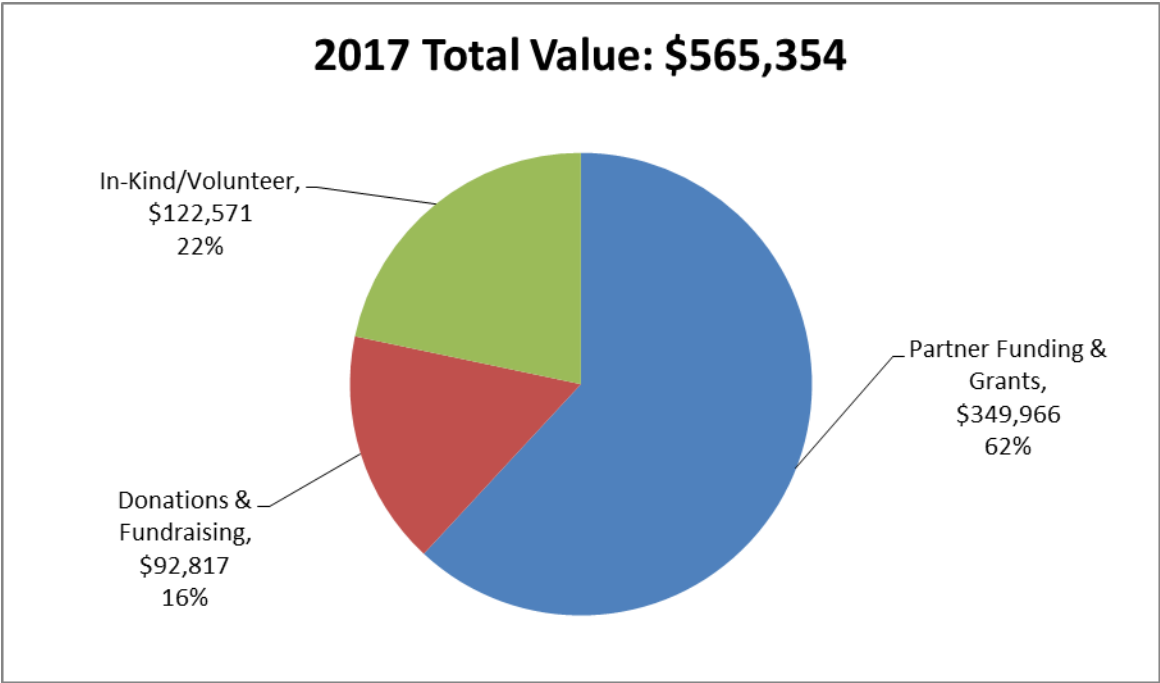
To date in 2018, new project funding has been secured by the South Canoe Trail Advisory through the Backcountry Horsemen Shuswap, EQ Trails, and Horse Council of BC to add another EQ trail connector to the existing trails. Two BC Parks Enhancement Fund grants carry through to support the Adams River Pictograph protection project and the Owlhead Recreational Access signage project. The City of Salmon Arm has committed project funding for greenway upgrade and signage priorities. And Recreation Sites and Trails BC and the Sexqéltkemoc te Secwepemc Lakes Division have confirmed funding to support the 4-year Shuswap Trails Roundtable proposal – other regional partners are reviewing the proposal.
